Jim Durkin served as an Assistant Illinois Attorney General.
Jim continued his public service as an assistant Cook County
state's attorney. In January 1995, Jim became an Illinois State
Representative in the 44th district. In 2006, Jim was
appointed to fill a vacancy in the 82nd House District and has
successfully run for re-election.

In August of 2013, Jim was selected by his Republican
colleagues to fill the vacancy of House Republican Leader and
was officially inaugurated by the full House of Representatives
on October 22, 2013.

He attended Illinois State University and earned a degree in
Criminal Justice, and completed his formal education by
receiving his Juris Doctor from the John Marshall Law School.
