#### Legislative Update



#### Big Issues Passed by Both Chambers

- SB 2800: Budget (Amendatory Veto)
- SB 2017: BIMP (Effective Date 6/17/2021)
- HB 2777: State Legislative Redistricting
- SB 642: Supreme Court Redistricting (implementation has been delayed by the Illinois Supreme Court)
- SB 825: Election Omnibus
  - March 15 primary moved to June 28
- HB 2908: Elected Chicago School Board
- SJRCA 11: Right to Organize



#### Big Issues That Haven't Passed Both Chambers

- Congressional Redistricting
- Energy Omnibus

# Tax Related Bills That Have Passed Both Chambers



# Budget Implementation Bill – SB 2017

- Eliminates the phase out of the franchise tax. The current \$1,000 credit will continue to be in place.
- Net operating loss suspension. Can only deduct \$100,000 per year. Applies to tax years 2021, 2022, and 2023.
- Decouples from bonus depreciation. First applies for the 2021 tax year.
- Foreign dividends:
  - For tax years ending on or after June 30, 2021.
  - Adds back GILTI deduction taken at federal level (IRC § 250(a)(1)(B)(i)).
  - Add back deductions under IRC § 243 (e) and IRC § 245A(a).
  - For dividend deduction, dividend does not include any amount treated as a dividend under IRC § 1248.
  - Dividend deduction does not apply to dividends for which a deduction is allowed under IRC § 245(a).

# Budget Implementation Bill – SB 2017 – Cont'd

- DCEO & DOR can adopt rules to extend EDGE credit unused due to COVID-19
- New Markets Development extension through FY 2024
- Extends the following credits through 2026
  - Affordable housing donation tax credit
  - Angel investment tax credit
  - River edge historic redevelopment tax credit
  - Live theater tax credit
    - Credit now applies to a commercial Broadway touring show in addition to pre-Broadway production.
  - Feminine hygiene products sales tax exemption



### Budget Implementation Bill – SB 2017 – Cont'd

- Prepared food sold prepared by an entity licensed by the Assisted Living and Shared Housing Act or an entity that holds a permit issued pursuant to the Life Care Facilities Act.
- Special valuation for supportive living facilities.
- Exempts trade schools from property taxes.
- Employer withholding tax credit for employers that allow employees to take 30 days of paid leave to be an organ donor or bone marrow donor. Maximum credit of \$1,000 per employee. Excludes vacation or sick time.



# IDOR Omnibus – SB 2279/P.A. 102-0040

- Extends the statute of limitations for a taxpayer's entire tax return by 6 months if a refund claim is filed when there is less than six months left in the original statute of limitations.
- Allows IDOR to look back 23 years (rather than 20) for any outstanding tax liability when issuing certificates of registration.
- EDGE credits recaptured by increasing the company's tax liability for the current year. Does not expand the scenarios for credits to be recaptured; merely changes *how* credits are recaptured.
- Changes how sports wagering winnings are sourced to Illinois for income taxes and requires withholding.
- Changes the notice requirements of bulk sales in the Income Tax Code to match the requirements in the Retailers' Occupation Tax Act. Notice of sales is to be 10 days before the sale, rather than within 10 days after the sale.
- Electronic cigarette substances with cannabis are not subject to cigarette tax.
- Makes technical changes to the Local Government Revenue Recapture Act. Institutes a \$2,500 fee for participants in the Certified Audit Program.

# Tax Bills

- SB 58: Repeals trade in credit limitation. Increases private motor vehicle transfer tax. Lowers license plate fee for trailers.
- SB 2066: Marketplace Facilitator. ROT exemption for marketplace sellers where the marketplace facilitator collected and paid use tax during 2020. Auctioneers exempt from statute, but not internet auction listing services.
- SB 2531: Pass through entity optional tax. (federal SALT limitation workaround)
- SB 508: Property Tax Omnibus
  - Does not contain Cook County Assessor's income and expense reporting proposal or the physical description reporting.
  - Southwest Home Equity Assurance Program
  - Recapture levy for PTELL districts
  - Tax sale provisions



#### **Issues Still Out There**

- SB 860: Cook County Assessor Initiatives
  - Income & expense disclosure
  - Physical description disclosure
- SB 1794/HB 731: Local utility tax audit "reforms"
